C. 2.8% Pay Increase – Sheriff Russell said that dur to the elected officials receiving a pay increase his budget would be including one for his employees as well. He noted that he had zero turn over since the last pay increase and the department was fully staffed. D. Vehicles – Sheriff Russell advised the Board that in order to keep well working vehicles within the department he would be requesting 3 new vehicles in his budget.
